ASSOCIATION EXPECTATIONS of you:-

- 1. By joining our Team Pennants, you become a member of our St George and Sutherland Shire Table Tennis Association (SSTT).
- 2. You will abide by the Constitution and bylaws of the Association.
- 3. You will abide by the RULES & REGULATIONS of Table Tennis as released by ITTF and as amended by the Association.
- 4. TEAMS/PLAYERS WILL SETUP TABLES ETC..AT THE START OF THE NIGHT. (USUALLY YOUR TABLE ONLY).
- 5. YOUR TEAMS WILL BE ROSTERED ON TO PACKUP AT THE END OF THE NIGHT. SHOULD THE TEAM NOT HELP PACK UP, POINTS MAY BE DEDUCTED FROM YOUR POINTS SCORE. (REFER OUR BYLAWS).
- 6. We expect your team will NOT FORFIET any match, a reserve list of players is on our website. (two players is better than NONE).
- 7. The maximum number of players per team is 6 players.
- 8. When applying for a grade a player's Rating Central Rating should be between the range the committee sets for each grade.

Division Grading Guidelines (Rating Central)

- Div 1 Above 1550
- Div 2 1550 1350
- Div 3 1350 1150
- Div 4 1150 900
- Div 5 Under 900

Racket Control All rackets need to be compliant with ITTF regulations. Racket control testing may be conducted.

Motion and picture Participants release all rights Participants may be videoed or photographed by the SSTT Marketing / social media Team. These videos / photographs may be used on Social Media platforms such as YouTube, Facebook and Instagram. Participants release all rights, or rights held by their agents or sponsors, in all matters relating to television and web casting coverage, video and motion picture coverage and photographic coverage of any kind to SSTT. Participants may video their own matches subject to their opponent(s) not objecting. Participants may not video matches in which they are not participating.

Betting In the context of betting, participants shall not, by any manner whatsoever infringe the principle of fair play, show unsporting conduct or attempt to influence the course or result of a competition or any part thereof in a manner contrary to sporting ethics. Any violation of this principle shall be disciplined according to provisions of ITTF Regulations 3.5.3.

Anti-Doping All members, participants and non-participants are required to read and understand and agree to abide by the Australian National Anti-Doping Policy, effective from 1 January 2021, and found on the Sport Integrity Australia website (https://www.sportintegrity.gov.au/what-we-do/anti-doping/world-anti-dopingcode/australian-nationalanti-doping-policy), being the anti-doping policy adopted by TTA and applicable to all members, participants and non-participant.
